Natural questions come out of this Environmental Ethics:



Third characteristic is that it is an interdisciplinary matter i.e. Environmental Ethics is not based on a single issue or region; rather it includes different principles of environment, environmental laws, literature and politics.

Fourth characteristic is that it is plural in nature because Environmental Ethics is the resultant of Anthropocentrism, Egocentrism and Biocentrism.

Fifth characteristic is that it is revolutionary in nature because Environmental Ethics criticizes Capitalism and discuss the necessity of coexistence of all species of Nature.



According to them every species has right to live in natural environment and man has no right to disturb their natural habitats and man should show the responsibility of not disturbing environmental balance.



Relationship between Environmental Ethics and Environmental Studies:

Firstly in the discussion of environmental studies, the Biologists and the Ecologists differ with one another. Where the Biologists give importance to the history of evolution of different species, the Ecologist give importance to ecosystem, i.e.the different elements of environment and their mutual action and their effects on environment. But Environmental Ethics give clear direction how to conserve environment by drawing attention of human beings .In short if Environment studies is the problem, Environmental Ethics is its solution.

Secondly Environmental Ethics gives clear directions to the workers of Environmental Studies on which fields they should work. Environmental ethics speaks that environmental pollution causes climate change and human beings must work together to resist environmental pollution. In Hadis 2320 it is taught that when a Muslim plants a tree or sow crops for cultivation, he is doing the best job for Allah because the fruits of that tree or the crops of his land will provide food to man, animals, birds. Tree is the most important 'Niyamat' of all the 'Niyamats' as Allah has given to mankind for their livelihood on earth.
